# 8. CHAMBER OF COMMERCE

Ald. Miller arrived at 7:10 pm.

President Maragret Perrault delivered her report on the recent and upcoming activities of the Chamber of Commerce. Please view the recording for comments in full.

She introduced her guest, Mike Kandah, owner of Smarty Pants Cafe. Kandah spoke about his business, which is a neighborhood cafe that serves coffee and tea and hosts science-based events and talks.

Motion by Ald. Uher, seconded by Ald. Beck, to approve the resolution. Motion carried 12 yea/ 0 nay/ 2 absent.

10. ORDINANCE 23-37: Establishing A Six Month Moratorium On The Acceptance And Processing Of Certain Building And Zoning Applications For The LI – Light Industrial And GI – General Industrial Properties In The SRS – South River Street Gateway Overlay District In Place Of The Truck Regulations (DR 7/21/23 COW 7/25/23 8/6) CD

Scott Buening presented the ordinance. Ald. Chanzit asked if the City had an opportunity to speak with landowners concerned. City staff responded that it had.

Mayor Schielke invited members of the audience to offer comment. Kate McCracken rose to address the City Council. McCracken requested that the city ordinance exempt a singular parcel of property from this ordinance owned by her client.

Ald. Chanzit stated that the city council has been telegraphing intent to improve this gateway property for a long time. Ald. Uher suggested that he would be more willing to consider exemptions on any other parcel.

Motion by Ald. Uher, seconded by Ald. Malay, to approve the ordinance. Motion carried 11 yea/ 1 nay/ 2 absent.

# 11. RESOLUTION 23-099-R: A Resolution Supporting A Design Concept For Configuration Of The River And Depot Pond In The Event Of Removal Of The Batavia Dam (LN 7/20/23 COW 7/25/23 8/6) GS

City Administrator Newman presented the resolution.

Ald. Solfa inquired about the timeline for funding availability. Administrator Newman answered that the Illinois Department of Natural Resources may at any time decide to terminate the funding program. She also mentioned that there may be additional funds available in the future in light of new study results from the U. S. Army Corp of Engineers. Discussion ensued.

Ald. Miller said that he did not believe that the engineering study would provide valuable new information that would prefer Option B to Option A.

Ald. Lanci asked what would happen in the event of a disagreement with the Park District. Administrator Newman suggested that there would be no movement on this issue.

Ald. Pieper asked additional questions about an engineering study.

Ald. Beck asked what an engineering study would cost. Administrator Newman answered that she would not be able to provide a ballpark figure for that

Ald. Chanzit suggested that to not take any action would necessitate a crisis response, rather than a managed one. He said he would prefer to make a mistake than to refuse to take action.

Ald. Solfa suggested that not approving Option B would not necessarily prevent choosing Option A. Discussion ensued.

Ald. Beck asked at what point the project would be submitted for approvals to IDNR or the Army Corp of Engineers. Administrator Newman responded that all these governing agencies would approve would be the dam removal and bank stabilization. She anticipated that the next stage of engineering would not begin until 2024, even if the resolution were to be approved in this voting session.

Mayor Schielke encouraged the Council to approve the resolution.

Motion by Ald. Uher, seconded by Ald. Malay, to approve the resolution. Motion carried 8yea/ 4 nay/2 absent.

12. RESOLUTION 23-101-R: Authorizing Execution Of A Notice Of Award To IHC Construction Companies LLC For Phase IIA Rehabilitation Improvements To The Wastewater Treatment Facility (GPH 7/24/23)

Motion by Ald. Malay, seconded by Ald. Uher, to approve the resolution. Motion carried 12 yea/ o nay/ 2 absent.

He encouraged residents to display these signs proudly. He noted that Illinois is on track to break the state's previous records for the highest number of traffic fatalities.
